

The Village of Arpin Board has determined the following rules for renting the Municipal Building or Kandy Kane Park.

# Rental & Deposit Fees per day:

- Municipal Building: \$110 rental fee + \$50 cleaning fee = \$160.00.
- Kandy Kane Park: \$100 rental fee + \$50 cleaning fee = \$150.00.

Local non-profit organizations rental fee will be waived upon approval of the Village Board, non-profit organizations will be required to pay the cleaning deposit

## **Reservations:**

- All reservations must be made with the Village Clerk office.
- Reservations will be on a first come first serve basis. Consecutive reservations will be allowed on weekdays only.
- The rental fee and cleaning deposit must be paid to reserve the date. The Village Clerk's office shall be notified of any reservation that is to be canceled. Please see cancellation process.

## Agreement:

- Cleaning fee will only be refundable if the building is left in clean condition. Kitchen and bathroom area must be cleaned after your event. Floors swept and mopped. Cleaning supplies are located in each bathroom under the sink and in kitchen. Mop, mop pail, broom and dustpan are located in closet, along with extra chairs. Garbage must be emptied and put in dumpster located outside. Garbage bags will be kept under kitchen sink. Chairs and tables should be arranged the same as you saw when you came. The \$50 cleaning fee will be returned following the Village of Arpin's next monthly meeting (2<sup>nd</sup> Wednesday of the month).
- All doors must be locked when you leave the building.
- All windows must be closed and latched.
- Tent stakes and canopies require prior approval from the Village of Arpin Board.
- Parking is only allowed in designated areas.
- The renter must be at least18 years of age. For activities that include alcohol, the renter must be at least 21 years of age.
- It shall be the responsibility of the renter to obtain any necessary permits or licenses required, and to abide by all state laws, as well as Village ordinances, resolutions, and policies.
- No open burning, i.e., fire pits, fire rings on Village grounds.
- The Village of Arpin is not responsible for any injuries, accidents, damage to the renter's property, or legal actions while during the course of the rental. Renter assumes all liability for the duration of the event.

## **Cancellations:**

If a reservation is canceled before 30 days of the rental date,  $\frac{1}{2}$  of the deposit will be returned. If reservation is canceled 30 days or less of the rental date, no refund will be issued.
