4. **Clerk/Treasurer Report:** Discussed multi-family residential on parcel 3200144; variances would need to be given and Village zoning would need to change for this to be an acceptable building lot. Ordinance #10, wording in Section 2 was discussed.

5. **Fire Department Update:** There were 10 calls this month: 2 Fire and 8 EMS. The total calls for 2026 are now 79.
6. **Public Works:** No sidewalk quotes were received; will look into grinding the sidewalk. Reviewed road work, municipal building parking lot and drainage estimates.

MOTION (Jack Esser/Dan Mrotek) to hire Becker Trucking to remove the municipal building asphalt, concrete sidewalks and decorative rock and replace with ¾" road base and to reshape the grade on the north side of the municipal building to allow for proper drainage. Carried 3-0.
7. **Post Office:** Reviewed estimates for parking lot blacktopping.
8. **KKP Maintenance:** Tree trimming will need to be completed within the park; contractors will be asked to review their estimates to narrow the scope of the project.
