

ORDINANCE NO. 22

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF ARPIN, WISCONSIN.

The Village Board of the Village of Arpin, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. (Direct Annexation) In accordance with S. 66.021 of the Wisconsin Statutes of 1975, and the petition for direct annexation filed with the Village Clerk on the 9th day of June, 1979, signed by a majority of the electors residing in the territory and the owners of 1/2 of the real property in assessed value and over 1/2 of area in the territory, the following described territory in the Town of Arpin, Wood County, Wisconsin is annexed to the Village of Arpin, Wisconsin:


The West one-half of the Northwest Quarter (W 1/2 of NW 1/4) of Section Twenty-seven, (27), Township Twenty-four North (24N), Range Four East (4E); the South 660' of the Southeast Quarter of the Northeast Quarter (SE 1/4 of NE 1/4) (intending to include all of the said forty lying South of the Village limits); and the Southeast Quarter of the Southwest Quarter of the Northeast Quarter (SE 1/4 of SW 1/4 of NE 1/4) (10 acres) all in Section Twenty-eight (28), Township Twenty-four North (24N), Range Four East (4E), and a part of the Southwest Quarter of the Southwest Quarter (SW 1/4 of SW 1/4) of Section Twenty-two (22), Township Twenty-four North, Range Four East, more particularly described as follows: Beginning at the Southwest corner of said Section 22, run thence East along the South line of said Section a distance of 244'; run thence northerly along the abandoned railroad right-of-way a distance of 338.75'; run thence West a distance of 271' to the West line of said Section; run thence South along the West line of said section a distance of 338' to the point of beginning; all of the above-described real estate being in the Town of Arpin, Wood County, Wisconsin.

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the Village of Arpin for any and all purposes by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Arpin.

SECTION 3. Procedure. The Clerks of the Village and Township of Arpin, the Clerk of the Auburndale School Board, as well as the Department of Local Affairs and Development were all notified as prescribed by State Statutes. There were no objections filed. We assume this annexation is in the best interest of the public.


SECTION 4. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 5. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
